SECTION I. ACCOUNTS

GENERAL PROVISIONS

1. This tariff regulates the standard terms and conditions for interests, commissions, fees and other charges applied by Texim Bank AD in case that no other terms and conditions have been agreed upon between the bank and its clients or correspondents under particular transactions.

2. Banking commissions, fees, interests and other charges are collected in Bulgarian leva and euro/US dollars depending on transaction currency. If the transaction currency is different from euro/US dollars and the commissions, fees, interests and other charges are determined in euro then they are calculated in euro based on the central exchange rate quoted by the Bulgarian National Bank for the respective day.

3. The BGN equivalent of fees and commissions under BGN transactions determined in foreign currency is calculated based on the central exchange rate quoted by the Bulgarian National Bank for the respective day.

4. The appendices on the minimum opening and operating balances on bank accounts as well as for the interests charged by Texim Bank AD on bank accounts in domestic and foreign currency are an integral part of this tariff as well as the charges applied for basic bank accounts.

5. Within the meaning of this tariff the legal entities are:

- Companies within the meaning of the Commerce Act;
- Legal entities within the meaning of the Non-profit Legal Entities Act;
- Non-personified companies /incl. the companies under the Act/;

- Legal entities, by virtue of special laws (including but not limited to law firms under the Bar Act, owners associations under the Condominium Management Act, etc.)

- The persons under Art.2 of the Commercial Law.
